### **Circular 34 of 2021: Administrators and Managed Care Organisations Accredited by the CMS Council**

The Council for Medical Schemes (CMS) hereby confirms that the Executive Committee (EXCO) of Council considered and resolved to approve the renewal of accreditation/compliance certificate of the organisations /medical scheme listed below, at its meeting of 28 May 2021.

#### **Managed Care Organisation - Renewal Applications**

1. **HaloCare (Pty) Ltd:** Renewal of accreditation was granted for a period of 2 years from 27 July 2021, in respect of the following services, with the conditions as stipulated on the CMS [website](#):
  - a. Active Disease Risk Management Services
    - Oncology
    - HIV
    - Diabetes Mellitus (Type 1 and 2)
    - Asthma/COPD/Bronchiectasis
    - Depression
    - Hypertension
    - Maternity
