Circular 21 of 2022: Revised Healthcare Utilisation Annual Statutory Return

The Council for Medical Schemes (CMS) hereby publishes version 10 of the updated <u>technical guideline document</u> for completing the Utilisation section of the 2020/2021 Annual Statutory Return (ASR).

The system is live, and schemes are encouraged to familiarise themselves with it well before the deadline for submission. No extension on deadlines will be granted. Schemes should note the following important data submission dates aimed at giving schemes enough time to work through changes, ensuring accurate and complete submissions.

Data officers will receive notification of the schemes that must resubmit the 2020 data submission for part C.5 as data errors were identified on this section.

The final signoff report can be electronically signed, if the scheme has the option available, however, schemes may submit the scanned signed document to the CMS by 10 June 2022 to <u>b.khuzwayo@medicalschemes.co.za</u>.
