Circular 39 of 2023: Healthcare Utilisation Annual Statutory Return

The Council for Medical Schemes (CMS) hereby publishes version 10.0 of the [technical guideline document](#) for completing the Utilisation section of the 2021/2022 Annual Statutory Return (ASR).

The ASR Healthcare Utilisation system is operational, and medical schemes are encouraged to submit data by the deadline listed in the table below. Medical schemes should take note of the following crucial data submission deadlines, which are intended to allow medical schemes ample to gather the data and ensure accurate and complete submissions.

Deadlines	Description	Due date
Electronic data submission	The deadline for electronic submission of schemes data	03 November 2023
Feedback reports	Feedback to schemes on data submission and possible resubmission of data	06 November 2023
Resubmission of data	Resubmission of data due to errors identified in feedback reports	10 November 2023
Final signed-off report	Final report signed off by PO and Trustees	17 November 2023

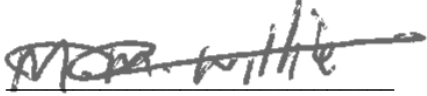
Please note that no changes have been made to version 10.0 of the technical specification documents. Version 10.0 of the technical guideline document should be read in conjunction with the following updated documents.
